- The submission must conform to the BLUEBOOK 19th Edition.
- Submissions are accepted only in electronic form.
- Submissions should not be simultaneously considered by any other publication.
- Co-authorship is allowed up to two authors.

- The manuscript(s) should be supported by a plagiarism check certificate which should not exceed 10%. Along with that a declaration must also be attached stating the originality of their submission.
- The author will be informed about the selection of the paper after review by the expert members of the review committee.
- The word limit exclusive of footnotes are as follows –
- Abstract: – 300 words (maximum 5 keywords)
- Research paper :- 4000 - 7000 words
- Articles (short/long): – 2000 - 4000 words
- Case analysis :- 1500 – 2000 words
- Book review :- 1000 – 2000 words
- The deadline for the submission of manuscripts is 30th May, 2023.
- The manuscripts which could not be published in the present volume shall be reviewed for the next volume on a rolling basis.
- Certificate of publication will be available in the official website of NEF Law College.
- Hardcopy of the journal will be sent in due course of time.
- The details of Author including designation, contact number, e-mail id and full postal address must be attached as a covering letter so that the journal could be sent by post.
